'Changing Landscape of Textbooks' at Council 3/16

All faculty members are welcome to attend the next Faculty Council meeting, which will be held **Friday, March 16, from 3-5pm** in the Sonja Haynes Stone Center for Black Culture and History. The agenda features a panel discussion about “the changing landscape of textbooks,” that will include attention to the challenges and opportunities of e-textbooks, the changing economics and logistics of textbook purchasing, and other textbook-related issues raised by Faculty Council members.

The Council will also hear annual reports from the Administrative Board of the Library, the Committee on Copyright, the Buildings and Grounds Committee, the Committee on the Status of Women, and the Committee on University Government. A resolution from the Committee on Student Conduct will be presented, along with two proposed Faculty Code amendments from University Government. The Provost will provide a progress update on the Academic Plan implementation, and Chancellor Thorp will update the Council in the wake of the release of the NCAA’s sanctions on Monday.

Faculty Elections Coming, April 16–23

The annual elections for Faculty Council and eleven facultywide standing committees will be conducted **April 16-23** via email survey sent to each member of the Voting Faculty. Although there is no election this year for Chair of the Faculty, there will be important elections for crucial policymaking bodies including Faculty Council; the Educational Policy Committee; Faculty Athletics Committee; campus-level Appointments, Promotions, and Tenure Committee; and Faculty Executive Committee. We’ll have our annual Voter Guide available in early April, both on the web and in the University Gazette. Then, watch your email on April 16th for the link to your individualized ballot. Faculty participation in elections has been creeping upward in recent years – let’s keep that trend going!

Campus Site License for Qualtrics Web Survey Research Tool

The Office of the Vice Chancellor for Research, Office of Institutional Research and Assessment, the Odum Institute, and ITS have recently announced that we now have a campus site license for Qualtrics, a web-based survey research tool. Previously, Odum's license covered only some campus units, but beginning March 1, 2012, access is available free of charge to anyone with an Onyen. Qualtrics has also now been approved by UNC for studies that collect sensitive information (including PHI) from a respondent. Users are reminded that all research involving human subjects must be reviewed by the UNC IRB prior to contact with subjects.
