### **Summary of Committee Charge:**

The Faculty Grievance Committee (FGC) is authorized to hear and advise on all grievances raised by members of the faculty aside from grievances concerning tenure decisions and issues relating to the termination of employment, which are under the jurisdiction of the Faculty Hearings Committee. The FGC also hears appeals of complaints filed by members of the faculty with the University's Equal Opportunity and Compliance Office (EOC).

#### Actions taken in the 2023:

The outgoing 2022-2023 co-chairs report that one grievance was filed and resulted in a hearing in the 2022-2023 academic year, one grievance was filed and formally withdrawn, and one grievance was filed and is still in process. Additionally, the chairs had numerous informal discussions with faculty members to discuss potential grievances, but none proceeded to a formal grievance.

Since July 2023, the current co-chairs have continued to field inquiries from faculty members to discuss potential grievances and are preparing for a potential hearing in the matter begun during the former chairs' tenure.
