## Advisory Committee Description and Charge [excerpted from The Faculty Code (§ 4-5)]

The Advisory Committee consists of nine elected members, the chair of the faculty, the secretary of the faculty, and the chair of the Committee on Appointments, Promotions, and Tenure. The committee is advisory to the chancellor in any matter deemed important by the chancellor or the committee, and particularly with respect to: trustee policies and procedures; academic policies and programs; appointment of vice chancellors, deans, and other senior administrators; recommendations for corrective action pursuant to a report of the Faculty Hearing Committee or Faculty Grievance Committee; and appointment and renewal of appointment of the faculty marshal and appointment and review of the faculty athletics representative. The committee nominates candidates for election as stipulated in the Faculty Code for chair of the Faculty and Secretary of the Faculty and advises the chancellor on the appointment and renewal of the Faculty Marshal and the Faculty Athletics Representative. These responsibilities are described in Sections 3:1-5 of The Code.

## Activities and Key Actions Spring 2023 - March 2024:

The monthly Advisory Committee meetings included information sharing from both the chancellor/interim chancellor and committee members, as well as requests for thoughts, feedback, questions, and considerations from both. The largest portion of meeting time has been devoted to hearing updates from the chancellor, responding to his requests for advice and sharing perspectives on key campus issues.

## Ongoing topics of discussion included:

- Review of process to Select nominees for Chair of the Faculty Elect: In accordance with the code change approved by the Faculty Council in fall 2022, the Chair of the Faculty Elect will serve for one year. The role will be included in the 2025 election. Documents defining the role of the Chair of the Faculty Elect are being updated to include information about the time commitment required for the role and updated timeline for the nomination process.

- Updates on the Gender Equity Task Force created in response to the salary equity data compiled by the Status of Women Committee
- Status and concerns regarding the GA Faculty Work-Load Policy proposal.

- Updates on Campus Mental Health support and increased security measures
